## **Operational Rules and Regulations**

1. All assessments and dues shall be due and payable February 1 (beginning of the fiscal year). Payments may be made in four equal payments Feb. 1, April 1, June 1 and Sept. 1. Any payment not received by the fifteenth day of the month in which it is due will be charged a penalty, the amount of same to be established from time to time at the annual meeting of the Members.

2. The members annual assessment and work credit shall be as established from time to time at the annual meeting of the Members-and will be given for working two (2) eight (8) hour days on assigned work projects.

3. The corporation shall have one (1) shooting member at all times. There may be more than one shooting member if the corporation is holding a membership stock in treasury. The shooting member's annual fee shall be established from time to time at the annual meeting of the Members. A Member of the corporation must sponsor shooting members.

4. A standby shooting members list is maintained by the Secretary. The sponsoring Member must submit in writing to the secretary the name, address and phone number of a proposed shooting member. The name or names will be added to the list in the order in which they are received.

5. Membership is expected to contribute 16 hours of work in planned or scheduled maintenance or improvement projects each year. The Board of Directors reserves the right to supplemental billings or credits subject to membership-approved guidelines.

6. The Board of Directors will make all decisions regarding work projects (per annual meeting).

7. Power equipment is to be operated only by members assigned to said equipment.

8. The maintenance of the ranch facilities is the joint responsibility of all members of the corporation. All maintenance problems should be called to the attention of the appropriate committee chairman or a member of the board of directors.

9. There shall be a set of the By-Laws of this corporation posted to our website at http:/stillbowranch.com. The By-Laws shall be reviewed and updated following each annual meeting.

10. There shall be a set of Operating Rules and Shooting Rules posted to our website at http:/stillbowranch.com. These rules shall be reviewed and updated periodically by the board of directors.

- 11. Subrogation of Shooting Privileges
  - a. If a member finds that he is unable to exercise his shooting privileges, for reasons that are substantially beyond his control, he may request, in writing, that the Board of Directors approve subrogation of those privileges. (The Board may be expected to look favorably on requests made for reasons such as illness, injury, or conditions of employment.)
  - b. A member may nominate the person to whom he wishes to subrogate his shooting privileges. The nominee must be one of the persons that the member is entitled to bring as a guest on Opening Weekend. The cost for the nominee to shoot shall be the same as for a member.
  - c. If the member has no nominee, the Board shall offer the shooting privileges to those persons on the Shooting Member List, starting at the top of the list and proceeding sequentially thru the list. This second shooting member shall pay to Stillbow Ranch Inc. the same fee as a regular shooting member. The Club shall then refund to the member that portion of his yearly assessment, which has been paid. If a person on the shooting member list declines the offer to shoot, he shall lose his place on the list.
  - d. A member may subrogate his shooting privileges no more than once every 10 years. Application to subrogate must be made prior to the start of the season and is allowed only for an entire season. If a member shoots any part of a season, he may not subrogate shooting privileges for the remainder of that season.
- 12. Privileges for Women
  - a. Women are granted guest privileges for all events sponsored by Stillbow Ranch Inc. Events occurring during the hunting season will be coordinated with women's shooting dates. The dates of all events are to be published in advance.
  - b. Women may stay over night at the Club on nights prior to shooting days, and after any events held in the evening. A Member who invites a women guest is
